

Reporting Unemployment Fraud

Resource Guide Revised: June 2020

The following is a state by state list of resource links that can be used for reporting unemployment fraud to a state UI agency. To clarify the correct use of columns below:

- <u>Claimant</u> for use by an individual worker who is the victim of identity theft, to report any suspicious incident to the UI agency, or to report someone believed to be collecting fraudulently
- <u>Employer</u> for use by any concerned party to report fraudulent activity being conducted by a company/employer, for example: worker misclassification and fictitious employer schemes

Any worker who finds themself the victim of an imposter UI claim should utilize the following 3 bullet points. It is critical that the impacted individual utilize these directly and not the employer. During the reporting process, information will be solicited to which only the individual will have access.

- Report the incident to https://identitytheft.gov/ which is managed by the Federal Trade Commission
- Contact his/her local police department and file a report (when possible)
- Report the incident to the state in which the imposter claim was filed using the "Claimant" links below
