

## **Trinity Health Standby Statements:**

- With the vaccine now only days away, we are turning a corner in this global health crisis. Trinity Health is confident in the safety and efficacy of the vaccine with the FDA approval. We strongly encourage everyone ages 16 and older to be vaccinated. We will not mandate vaccination for colleagues at this time.
- Trinity Health is actively preparing to begin immunization at various locations with the COVID-19
  vaccine as soon as locations receive the first shipments. Like all health systems, we are working
  closely with the CDC and state health departments, which have been charged with vaccine distribution.
- We are following CDC Advisory Committee on Immunization Practices (CDC ACIP) and state guidelines on vaccine distribution. Distribution is expected to begin within a few days. Locations will initially be limited to those selected by their state governing body.
- Trinity Health will also follow CDC recommendations for vaccine prioritization, including ensuring health care workers who wish to be immunized, and residents of senior care facilities receive the COVID-19 vaccine first. From there, we are determining the most efficient ways to distribute the vaccine to the community based on CDC ACIP prioritization and vaccine supply made available to us.
- Health care and essential workers and residents of long-term-care facilities will be among the first to receive the vaccine. Additionally, high-risk populations including older adults and people with underlying health conditions will also receive the vaccine as more vaccine becomes available.

- Trinity Health urges everyone to continue to follow current safety measures. It is crucial that we all
  remain vigilant with avoiding crowds, practicing physical distancing, mask wearing and hand hygiene.
  We must continue upholding our personal safe living and decision-making responsibilities until the
